<p>On 05/07/2018 at 2332 hours, I was dispatched to call RP1 CHERYL WINK (03/03/1972) regarding prior threats and an extra patrol request. RP1 CHERYL explained to the dispatcher that she was a City Council member, and earlier in the evening, City Council member SB1 LAURETT BARRENTINE (02/09/1958) had yelled at her during a Council Meeting at City Hall, located at 1000 Englewood Pkwy. RP1 CHERYL explained to the dispatcher that she wanted an extra patrol near her residence, located at 2980 S. Elati St., because she did not feel safe.</p> <p>I arrived in the area of RP1 CHERYL's residence and I called her. RP1 CHERYL explained that City Council had a meeting that started at 1900 hours. She explained that they eventually went into a special session meeting where certain concerns were brought up about SB1 LAURETT, who was in the process of being Recalled. RP1 CHERYL explained that since she was an At-Large Council Member, she speaks to members of the entire community, instead of in just one district. She stated that after the concerns were brought up about SB1 LAURETT, she (RP1 CHERYL) made a statement that she had heard similar concerns from citizens in the community. RP1 CHERYL stated that SB1 LAURETT then became very upset and yelled that no one had ever told her (SB1 LAURETT) any of that. RP1 CHERYL stated that SB1 LAURETT then "stormed" up to her and yelled, "Member Wink I helped get you elected!" RP1 CHERYL advised that she then told SB1 LAURETT that she (RP1 CHERYL) would not be yelled at. RP1 CHERYL advised that SB1 LAURETT followed her out of the meeting chambers and into the Civic Center 2nd floor lobby, where SB1 LAURETT continued to yell. RP1 CHERYL stated that she did her best to block out what SB1 LAURETT was yelling at her about, so she did not have any specific details, but to the best of her knowledge SB1 LAURETT did not make any direct threats. However, RP1 CHERYL explained that due to SB1 LAURETT's actions, she (RP1 CHERYL) did not feel safe, and she wanted us to conduct extra patrols around her residence throughout the</p>

Pearl St., where SB1 LAURETT lived, and I observed that she had a gold 2002 Suzuki XL7 (CO VQG-009) parked on the street in front of her home.

I sent out an MDT announcement to the on-duty officers and requested that they conduct extra patrols around 2980 S. Elati St. throughout the night.
